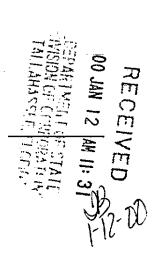

### ARTICLES OF ORGANIZATION FOR BRANNAN VENTURES, L.L.C.
