**ARTICLE I
Name**

The name of the limited liability company ("Company") is **SPORTANGLER, L.L.C.**

**ARTICLE II
Address**

**ARTICLE III
Duration**

**ARTICLE IV
Registered Agent and Office**

**ARTICLE VI
Admission of New Members**

Managers of the Company have the right to admit new Members in accordance with the Regulations of the Company.

ARTICLE VII
Continuation of Business

A majority in interest of the remaining Members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company.

ARTICLE VIII
Voting Rights

Each Member's vote on matters relating to the Company on which Members are allowed to vote will be weighted in proportion to their ownership interest percentage in the Company compared to all other such interests.

ARTICLE IX
Profits and Losses Allocation

Profits and losses will be allocated to the Members in accordance with the Regulations of the Company.

ARTICLE X
Amendments

These Articles may be amended by filing Articles of Amendment with the Florida Department of State signed by the Managers.

ARTICLE XI
Commencement

Pursuant to the provisions of Chapter 608, Florida Statutes, this Company shall begin in existence on January 17, 2000, at 12:01 A.M.

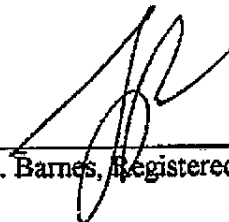
**CERTIFICATE OF DESIGNATION OF
