The Limited Liability Company shall be managed by its Managing Member in accordance with the Operating Agreement of the Limited

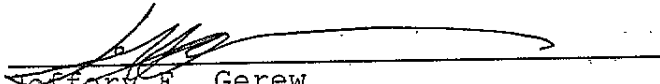
