FIRST: The date of the filing of the Articles of Organization was 19 January 2000.

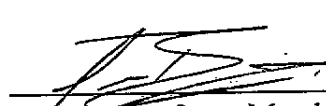
SECOND: The name of this Company shall be changed to **SPOTLESS, LLC**
