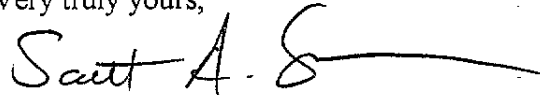

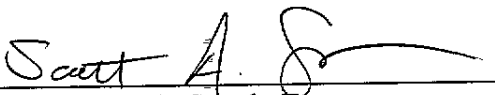

The Limited Liability Company is to be managed by one or more managers and is, therefore, a manager-managed company.

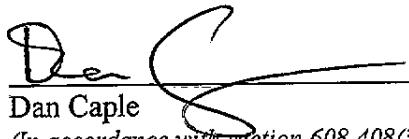
Article 9

No member shall have the right to demand the return of his or its contribution to capital except as provided in the Company's Regulations and Operating Agreement then in existence.

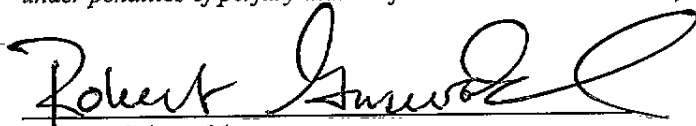
Article 10
