ARTICLES OF ORGANIZATION

OF

LAW OFFICE OF MICHAEL I. MILLER, P.L.

A PROFESSIONAL LIMITED LIABILITY COMPANY

The undersigned, who is duly licensed to practice law in the State of Florida and desiring to form a professional limited liability company in accordance with Chapter 608 of the Florida Statutes and the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company shall be Law Office of MICHAEL I. MILLER, P.L.

SECOND: The period of duration for the Limited Liability Company shall be thirty years.

THIRD: The Limited Liability Company is organized for the purpose of engaging in the practice of law within the State of Florida, and to take all actions that are necessary or proper in connection with that practice.

FOURTH: The mailing address of the Limited Liability Company is P.O. Box 1259, Sanibel, FL 33957 and the street address of the principal office of the Limited Liability Company is 2737 West Gulf Drive, #136, Sanibel, FL 33957.

FIFTH: The street address of the initial registered office of the Limited Liability Company in Florida is 2737 West Gulf Drive, #136, Sanibel, FL 33957, and the name of the initial registered agent of the Limited Liability Company in Florida at that address is Michael I. Miller.

SIXTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members.

SEVENTH: If there later is more than one Member, the remaining Members of the Limited Liability Company, by the affirmative vote or consent of Members holding 75 percent of the Members' Percentage Interests (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

EIGHTH: The Limited Liability Company will be operated by the Members, and no manager will be appointed. The name and address of the sole Member are: MICHAEL I. MILLER, having an address 2737 West Gulf Drive, #136, Sanibel, FL 33957.

NINTH: The professional services of the Limited Liability Company shall be rendered only through members, employees, and agents who are duly licensed or otherwise legally authorized to practice law within the state of Florida. Professional services shall be rendered in each case by the member, employee, or agent designated solely by this Limited Liability Company, acting through its members. This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of legal practice.
