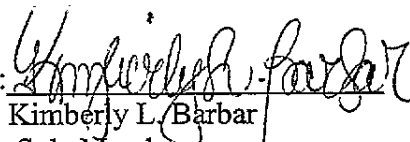

RESOLVED, to forthwith discontinue all business carried on by the Company and to dissolve the Company as of the date set forth in the Plan of Dissolution.

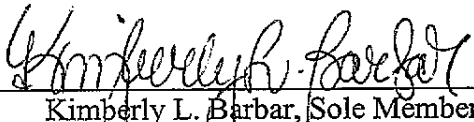
FURTHER RESOLVED, that the Director of the Company take all of the steps necessary to accomplish the dissolution of the Company.

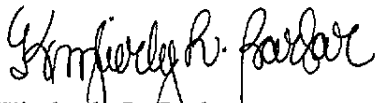
