# ARTICLES OF ORGANIZATION OF PRECISION AMMUNITION, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

#### 1. **NAME**.
