#### ARTICLES OF ORGANIZATION

**OF** 

#### B.I.G., LLC

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

#### ARTICLE I - NAME

The name of this limited liability company shall be B.I.G., LLC (the "Company")

# **ARTICLE II - DURATION**

The Company shall commence upon the execution of these Articles and shall exist perperually

## ARTICLE III - PURPOSE

The purpose of the Company is to engage in any lawful business activity that is not prohibited with respect to a limited liability company organized according to the laws of the State of Florida.

#### ARTICLE IV - ADDRESS

The number of initial managers, who shall serve as managers until the first annual meeting of the Members of the Company or until their successors are duly elected, shall be three (3).
