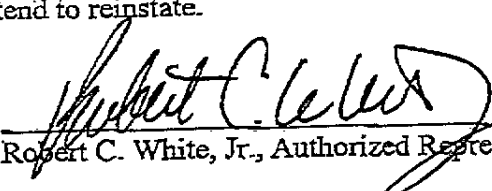

3. The Company does not intend to reinstate.

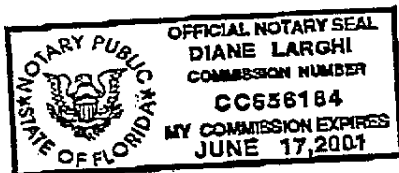

FIRST: The date of filing of the articles of organization was January 14, 2000.

SECOND: The following amendments to the articles of organization were adopted by the limited liability company:

ARTICLE I.

NAME.

The name of this limited liability company (the "Company") is Cenetec, L.L.C.

ARTICLE VI.

MANAGEMENT.

The management of the Company is reserved to a Board of Managers (the "Managers") to be elected from time to time.

ARTICLE VII.

ADMISSION OF NEW MEMBERS.

The Company may admit new Members only upon the approval of a majority of current Members, provided that each new Member assents to the terms and executes the Operating Agreement.

Except as otherwise provided in the Operating Agreement, these Articles of Organization and the Operating Agreement may only be amended by a vote of the Members who hold at least a majority of the then-outstanding membership units of the Company.
