
ARTICLE V

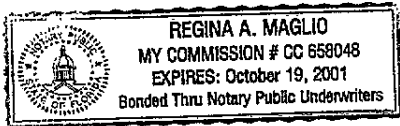

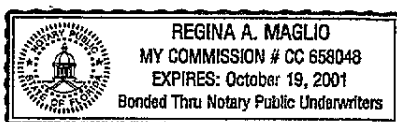
