ARTICLE II - Address

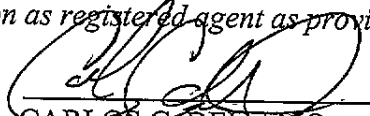

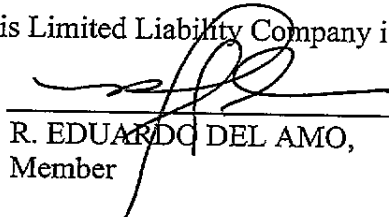
