## ARTICLES OF ORGANIZATION

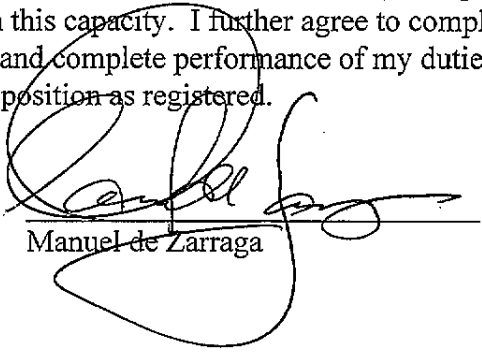
