ARTICLES OF ORGANIZATION OF CAPRAIELLA, L.L.C.

- 1. Name. The name of this limited liability company is CAPRAIELLA, L.L.C. (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
