ARTICLES OF ORGANIZATION OF MAITLAND BAY, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make acknowledge and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Maitland Bay, L.C. ("Company").

A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members
