The name of this limited liability company shall be MANPA, LLC.

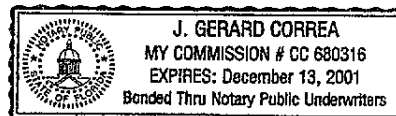


