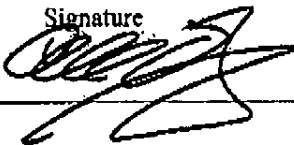

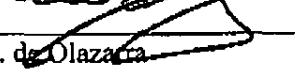
The undersigned, being the manager of America's Self Storage LLC, a Delaware limited liability company (the "Company"), does hereby consent and unanimously adopt the following resolution:
