**ARTICLES OF ORGANIZATION OF
LAW OFFICES OF ADRIAN P. THOMAS, P.L.
A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

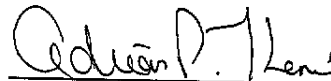
THE UNDERSIGNED, ADRIAN P. THOMAS, pursuant to Florida Statutes 608.407 does hereby execute these Articles of Organization of LAW OFFICES OF ADRIAN P. THOMAS, P.L. ("the Professional Limited Liability Company") for the purpose of forming a Professional Limited Liability Company under the Florida Limited Liability Company Act and the Professional Service Corporation and Limited Liability Company Act and does hereby state and set forth:

1. The name of the Professional Limited Liability Company is LAW OFFICES OF ADRIAN P. THOMAS, P.L..
2. The period of duration of LAW OFFICES OF ADRIAN P. THOMAS, P.L. shall be perpetual.
3. The mailing address and street address of the principal office of the Professional Limited Liability Company is 2729 N.E. 30th Avenue, Lighthouse Point, Florida 33064.
4. The name of the initial registered agent in Florida for the Professional Limited Liability Company is ADRIAN P. THOMAS and his street address is 2729 N.E. 30th Avenue, Lighthouse Point, Florida 33064. The acceptance of ADRIAN P. THOMAS as registered agent appears after the execution of these Articles of Organization below.
5. No members shall be allowed to admit additional members except by a unanimous vote of the voting members of the Professional Limited Liability Company, or upon such greater vote as may be prescribed by the Professional Limited Liability Company regulations.
6. The Professional Limited Liability Company shall not dissolve and the remaining members of the Professional Limited Liability Company shall continue its business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Professional Limited Liability Company.
7. The management of the Professional Limited Liability Company is reserved to its voting members. The name and address of the voting member of the Professional Limited Liability Company is:

All other matters regarding the relative rights of the voting and non-voting members of the Professional Limited Liability Company, and the operations of the Professional Limited Liability Company shall be determined by the Professional Limited Liability Company Regulations. The power to adopt, alter, amend, or repeal the Regulations of the Professional Limited Liability Company shall be vested in the voting members of the Professional Limited Liability Company.
9. Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.
10. The purpose of this Professional Limited Liability Company is to provide legal services through the operation of a law firm.
