**ARTICLES OF ORGANIZATION
FOR
DAVID P. RUPPERT, L.L.C.**

ARTICLE I

The name of the Limited Liability Company (hereafter referred to as the "Company") is:
David P. Ruppert, L.L.C.

ARTICLE II

The mailing address and street address of the principal office of the Company is:

ARTICLE III

The period of duration for the Company shall be for 39 (thirty-nine) years and eleven months beginning February 1, 2000 and ending on December 31, 2040.

ARTICLE IV

The Company is to be managed by the members and the names and addresses of the managing members are:

ARTICLE V

The right of the members to admit additional members and the terms and conditions of the admissions shall be:

- (i) A majority of the members of the Company shall be entitled to approve the admission of a new member. Each member shall have a vote according to his or her percentage of ownership of the Company.
- (ii) If a prospective new member is purchasing the company, the prospective new member must contribute an amount cash or assets equal to the fair market value of the assets of the Company less the liabilities plus an amount equal to 500% of the average net earnings of the Company up to the most recent five years.

- (iii) A member of the Company may sell his or her shares to a prospective new member providing that the remaining members (excluding the member selling) approve by two thirds majority. Each remaining member shall have a proportion of votes equaling to the total amount of his or her shares divided by the total amount of all members shares excluding the shares of the member wishing to sell his or her shares.

ARTICLE VI

The right of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company shall be granted providing that:

- (i) Unless otherwise agreed by the departing member or the personal representative of a deceased member's estate a departing member shall be entitled to compensation for his or her ownership in the Company in accordance with the following formula:

The fair market value of the assets of the Company less the liabilities of the Company

The average earnings up to the most recent 5 years multiplied by 500%
