

Part of the Southeast 1/4 of the Northeast 1/4 of Section 11, Township 10 South, Range 26 East, Putnam County, Florida, more particularly described as follows:

From the Southeast corner of said Southeast 1/4 of Northeast 1/4 run North and along the East line of said Southeast 1/4 of Northeast 1/4 for a distance of 66.00 feet to the Point of Beginning of the parcel of land to be described:

Thence continue North, along the East line of said Southeast 1/4 of Northeast 1/4, a distance of 393.00 feet to a point; thence West and parallel with the South line of said Southeast 1/4 of Northeast 1/4 for a distance of 538.00 feet; thence South and parallel with the East line of said Southeast 1/4 of Northeast 1/4 for a distance of 393.00 feet to the South line of that parcel of land conveyed to L. T. Hall, Trustee (O.R. Book 22, Page 591 of the Public Records of Putnam County, Florida) said South line being 66.00 feet North of the South line of said Southeast 1/4 of Northeast 1/4; thence Easterly and 66.00 feet from said South line of the said Southeast 1/4 of Northeast 1/4 for a distance of 538.00 feet to the Point of Beginning and to close.

SAVING AND EXCEPTING THEREFROM THE FOLLOWING DESCRIBED LANDS, TO-WIT:

(a) A strip of land for right-of-way described as follows:

From the Southeast corner of said Southeast 1/4 of Northeast 1/4, run North 166.00 feet to the Point of Beginning of the lands to be excepted hereof; thence North and along the East line of said Southeast 1/4 of Northeast 1/4 for a distance of 280.00 feet; thence West 38.00 feet; thence South 36.00 feet; thence East 8.00 feet; thence South 244.00 feet; thence East 30.00 feet to the Point of Beginning. Thence continuing Westerly in the same course, and along the Northerly boundary of the Gainesville Highway (State Road #20), 125.00 feet to a point; thence Northerly and parallel with the East line of said Southeast 1/4 of Northeast 1/4, 125.00 feet to a point; thence Easterly and parallel with the North line of said Gainesville Highway (the same being Call 1 above) for a distance of 125.00 feet; thence Southerly 125.00 feet to the Point of Beginning.
