**ARTICLE VII**  
**MANAGEMENT: APPARENT AUTHORITY**

The Company is to be managed by the member(s); provided, however, the member(s) shall elect a board of directors which, in turn, shall elect officers all of which will be as provided by resolutions passed by the members, By Laws adopted by the members or directors, and/or an operating agreement entered into by the member(s). No Member shall have authority to take or engage in any action, in its capacity as a Member, to bind the Company in any manner. This provision is intended to provide actual notice to those who read it, or should have read it, that the rules of apparent authority do not apply to this Company.

**ARTICLE VIII**  
**UNITS AND INTERESTS IN THE COMPANY**

The authorized Interests of the Company consists of ONE THOUSAND (1,000) Units (hereinafter sometimes called "Units" or "Interests"), with a par value of ONE DOLLAR (\$1.00) per Unit. Upon issuance of a Unit the Company Management shall identify in any certificate evidencing ownership of such Interests whether the Interest carries the properties of an Interest owned by a Managing Member or the properties of an Interest owned by a Member that is not a Managing Member.
