The members may admit additional members upon the unanimous vote of the then members of the Company.


ARTICLE VII – Right to Continue Business

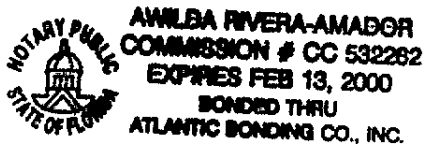



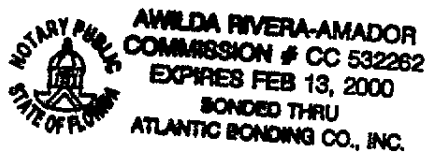
