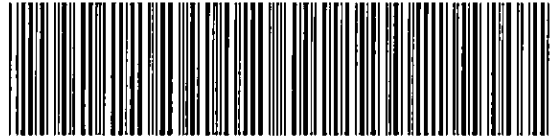

**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
SPECTRUM FIELD PRODUCTIONS, LLC**

Pursuant to Section 605.0202 of the Florida Statutes, **SPECTRUM FIELD PRODUCTIONS, LLC**, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization of the Company were filed on February 15, 2000 and assigned document number L00000001723.

SECOND: Article I of the Company's Articles of Organization is amended in its entirety to read as follows:


**"ARTICLE I
