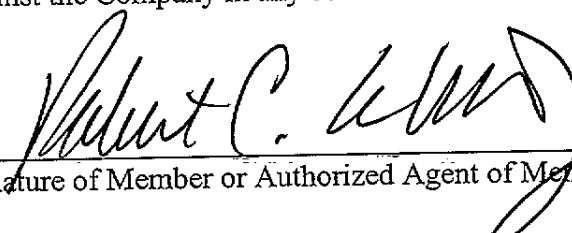

## ARTICLES OF DISSOLUTION
