ARTICLE I - Name

The name of this limited liability company shall be GITRO, LLC.

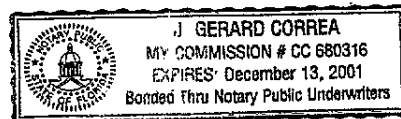


