TO: THE FLORIDA SECRETARY OF STATE:

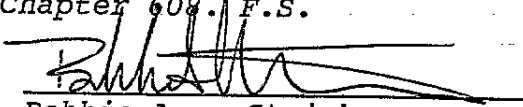
The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, does hereby execute the following Articles of Organization:

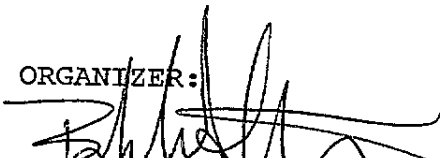
