# Merkantile Futures Fund #1, L.L.C. ARTICLES OF ORGANIZATION

### ARTICLE I. ORGANIZATION

- 1.1 <u>Formation and Name</u>. **Merkantile Futures Fund #1, L.L.C.** (the "LLC") is being formed under the Florida Statutes: Title XXXVI, Chapter 608.
- 1.2 <u>Purpose</u>. The LLC's business and purpose is to trade, buy, sell, spread or otherwise acquire, hold or dispose of commodity option contracts. (At any time, the scope of trading in commodity futures contracts and forward contracts on foreign currencies can be changed by a vote of the Managing Member and a majority of Members).
- 1.3 Term. The LLC effective date is February 14, 2000 and shall continue in existence until February 14, 2025, unless terminated earlier my the Members or by operation of law. The duration of the LLC may be extended by a vote of the Managing Member and a majority of Members.
- 1.4 Transferability of Units. Limited Ability to Liquidate Investment Units. Although a member may transfer his Units, no market exists for the Units and none is likely to develop. In addition, a transferee of a Unit can only become a substituted member with the Managing Member's Consent. While the Units are generally noncallable, the Managing Member has the authority under these Articles of Operation to require members that are employee benefit plans, IRAs and similar tax-exempt or tax-deferred investors and/or foreign investors to withdraw from the Fund under certain conditions.

#### ARTICLE II ADDRESS

Principal Offices. The LLC shall maintain its principal office at 201 Annwood Road, Largo FL 33777.
