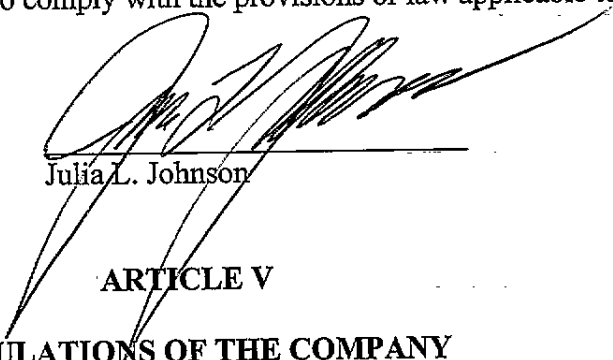

REGULATIONS OF THE COMPANY**

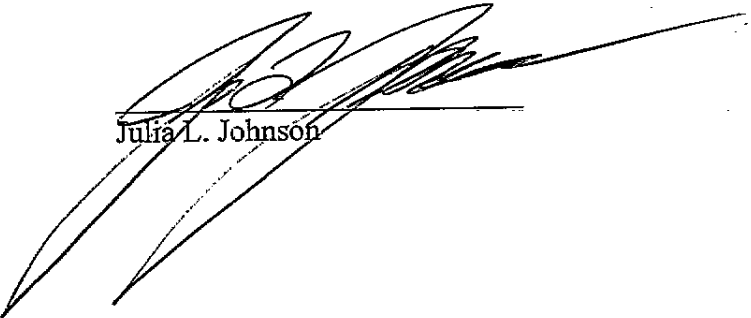
