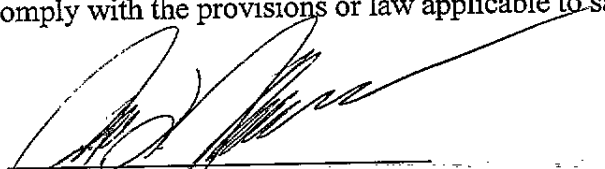

**REGULATIONS OF THE COMPANY**

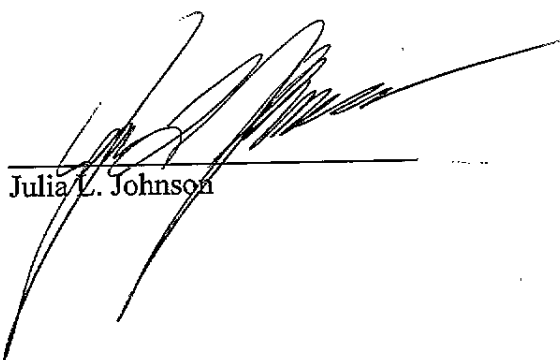
