ARTICLES OF ORGANIZATION

OF

BISCO Properties, LLC

The undersigned, as an authorized representative of a member of the Company, pursuant to Chapter 608, Florida Statutes, files the following Articles of Organization establishing a Florida limited liability company named **BISCO Properties**, **LLC**.

ARTICLE I

Name
