ARTICLES OF CORRECTION TO THE ARTICLES OF ORGANIZATION OF 505 LLC

The undersigned Managers of 505 LLC (the "Company"), a Florida limited liability company, pursuant to Section 608.4115 of the Florida Limited Liability Company Act, hereby adopt the following Articles of Correction to the Articles of Organization:

- The name of the Company is 505 LLC.
- 2. The Articles of Organization for the Company were filed with the Florida Department of State on February 21, 2000 and assigned number L00000001908.
- 3. Article III of the Articles of Organization of the Company is hereby corrected by inserting a new mailing address for the Company. Article III of the Articles of Organization shall be corrected to read in its entirety as follows:

Article III

Nature of Business and Mailing Address

This Company is organized for the purpose of transacting any or all lawful business.

The amount of capital which the initial two Members have committed as their initial capital contribution is One Hundred Fifty Thousand Dollars (\$150,000), which shall be paid entirely in cash. Additional capital contributions may be received and additional units issued at such times and in such amounts as may be determined and allowed as provided in the Regulations and Operating Agreement.
