Articles of Organization
of

Pursuant to the provisions of Section 608.407, Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of **Park Plaza Barbers, LLC**, a Florida limited liability company (the "Company"):

1. **Name.** The name of the Company is **Park Plaza Barbers, LLC.**

2. **Duration.** The Company shall exist perpetually.

3. **Purpose.** The company is organized to engage in and to do any lawful act concerning any and all lawful business, other than banking or insurance, for which a limited liability company may be organized.

4. **Principal Office.** The mailing address and street address of the initial principal office is as follows: 11125 Park Boulevard, Suite 104 #148, Seminole, FL 33772.


5. **Registered Agent.** The name of the initial registered agent is **John N. High IV**, whose business address is the same as that of the principal office.
