ARTICLE III – DURATION

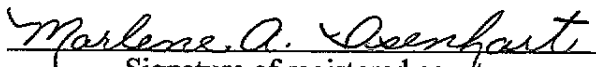
The period of duration of the Company shall be thirty (30) years, unless sooner dissolved by the members or as provided by the laws of the State of Florida.
