## Articles of Organization of F. W. ASSOCIATES, L. L. C.

The undersigned subscriber to these Articles of Organization, desiring to form a limited liability company pursuant to the Florida Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, and being a natural person competent to contract, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a limited liability company under the laws of the State of Florida.

#### ARTICLE I (NAME)

#### ARTICLE II (DURATION)
