ARTICLES OF ORGANIZATION

OF

LATIN AMERICA BASIC CHANNEL SERVICES, L.C.

The undersigned members to these Articles of Organization hereby associate themselves together to form a Limited Liability Company under the laws of the State of Florida.

ARTICLE I

NAME

The name of this Limited Liability Company is Latin America Basic Channel Services, L.C.

ARTICLE II

GENERAL NATURE OF BUSINESS

The Limited Liability Company may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

MEMBERSHIP
