

**ARTICLE III – DURATION**



#### ARTICLE V – ADMISSION OF ADDITIONAL MEMBERS


The limited liability company shall have no other manager until such time as the right, if given, of the members to admit additional members and the terms and conditions of the admissions of such amendment is filed.




