ARTICLES OF ORGANIZATION

OF TAMPA GATEWAY PARK TC PARTNERS, LLC

The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I

NAME

The name of the limited liability company shall be Tampa Gateway Park TC Partners, LC and its principal place of business and its mailing address shall be 214 Shore Crest Drive in the City of Tampa, County of Hillsborough, State of Florida 33609.
