## ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF 27 RESTAURANT COMPANY, LLC

This Articles of Amendment to the Articles of Organization of 27 RESTAURANT COMPANY, LLC is made pursuant to Florida Statutes Section 608.411 (1999).
