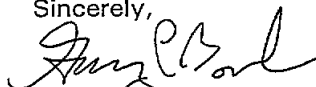

**ARTICLES OF ORGANIZATION
OF
JAWORSKI MANAGEMENT, LLC**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Florida Statutes Annotated Sections 608.401 to 608.471, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

Jaworski Management, LLC

SECOND: The latest date on which the Limited Liability Company is to dissolve is November 19, 2050.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Florida Statutes Annotated Sections 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Florida is Acton Management Services, 5738 Missouri Avenue, New Port Richey, FL 34652, and the name of the initial registered agent of the Limited Liability Company in Florida at that address is David J. Hanson.

FIFTH: The mailing address and principal office of the Limited Liability Company is 3632 Manor Drive, Highland, Indiana 46322.

SIXTH: The Limited Liability Company will be operated by the Members, and no manager will be appointed. The names and addresses of the Members are: Henry E. Jaworski and Shirley M. Jaworski,

SEVENTH: The total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the Members is \$200.00. The allocations and distributions of the Limited Liability Company shall be made in proportion to the Members' Percentage Interests.

TWELFTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.

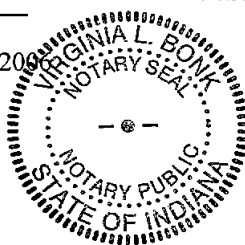

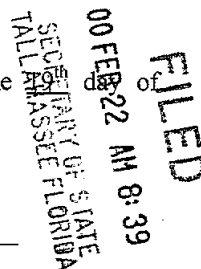

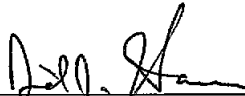
