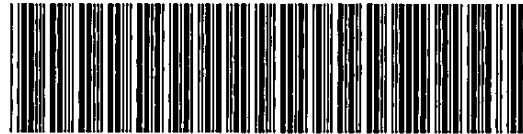

ARTICLE 2

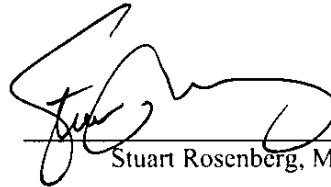
The date of filing of the Articles of Organization was February 29, 2006.
