### ARTICLES OF ORGANIZATION OF FS FARM, L.L.C.

The undersigned, being a Member and the Organizer of FS Farm, L.L.C. (the "Company") hereby being formed under Chapter 608, Florida Statutes, hereby files the following Articles of Organization for the Company:

FIRST: The name of the Company is:

SECOND: The latest date on which the Company is to dissolve is December 31, 2035.
