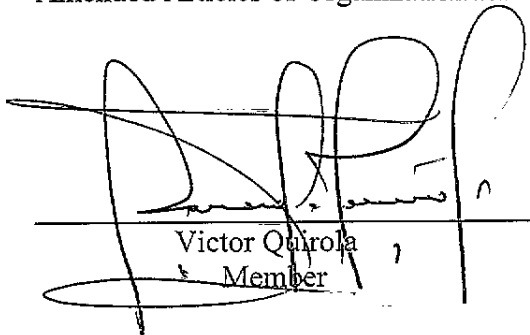
The following amendment of the Articles of Organization was adopted by the members of the Company on November 6, 2000. It was decided upon by a unanimous vote of the members:
