ARTICLES OF ORGANIZATION
OF
W. & S., L.L.C.

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company, Act, F.S., Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME

The name of the Limited Liability Company shall be W. & S., L.L.C., (the "company").

ARTICLE II
PRINCIPAL ADDRESS

The mailing address and street address of the principal office of the Company shall be 2007 S.E. Federal Highway, Boynton Beach, Florida 33435.

ARTICLE III
DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved in a manner provided by law, or as provided in the Operating Agreement adopted by the Members.

ARTICLE IV
INITIAL REGISTERED OFFICE AND AGENT

The name and address of the initial registered agent of the Company in the state of Florida is STEVE WOLFE, 2007 S.E. Federal Highway, Boynton Beach, Florida 33435.

ARTICLE V
POWERS

In addition to the powers authorized by laws of the State of Florida, the Company shall have all powers set forth in the Operating Agreement adopted by the Members.

ARTICLE VI MEMBERS RIGHT TO CONTINUE BUSINESS

The remaining members may continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member in accordance with the Operating Agreement adopted by the Members.

ARTICLE VII ADMISSION OF NEW MEMBERS

No additional Members shall be admitted to the Company except with the unanimous written consent of all Members of the Company and on such terms and conditions as shall be determined by all the Members. A Member's interest in the Company may not be sold or otherwise transferred except with the unanimous consent of all the Members or as otherwise set forth in the Operating Agreement of the Company.

ARTICLE VIII MANAGEMENT

The Company shall be a manager-managed Company, managed by two(2) managers in accordance with the Operating Agreement regulations adopted by the Members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. ARTICLE IX AMENDMENTS

The power to adopt, alter, amend or repeal these Articles of Organization shall be vested in the Members and shall be consistent with the Florida Limited Liability Company Act and the Operating Agreement.


