The undersigned hereby adopts the following Articles of Organization for the purpose of forming a Limited Liability Company under Florida Statutes Chapters 608.

**ARTICLE I.
NAME**

The name of the Limited Liability Company shall be SPYGLASS VENTURES LLC.

**ARTICLE II.
DURATION; EFFECTIVE DATE**

This Limited Liability Company shall exist perpetually, commencing as of the date on which these Articles of Organization are filed with the State of Florida Department of State.

**ARTICLE III.
