**ARTICLES OF ORGANIZATION**  
**OF**  
**WHITESAND INVESTMENTS, L.L.C.**

The undersigned, being authorized to execute and file these Articles on behalf of the members for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby certify and adopt these Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be "Whitesand Investments, L.L.C." ("Company").

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company shall be 815 South Palafox Place, 3rd Floor, Pensacola, Florida 32501.

**ARTICLE III - DURATION**

The Company shall commence on the date of filing these Articles of Organization with the Florida Department of State and the Company's existence shall be perpetual.

**ARTICLE IV - REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the Company in the State of Florida is Daniel R. Lozier, 125 West Romana Street, Suite 224, Pensacola, Florida 32501.

**ARTICLE V - CAPITAL CONTRIBUTIONS**

The cash and/or property contributed to the Company by its members and the members' obligations to make additional contributions to the Company shall be as prescribed in the Regulations of the Company as adopted and agreed upon by the members.

**ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS**

Members shall not have the right to admit additional members except with the written consent of all members and except as prescribed in the Regulations of the Company as adopted and agreed upon by the members. Members' interests in the Company may not be transferred except as prescribed in the Regulations of the Company as adopted and agreed upon by the members.

**ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS**

Upon the death, retirement, resignation, expulsion, bankruptcy, withdrawal, or dissolution of a member, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members of the Company shall not have the right to continue the business of the Company except with the written consent of all remaining members and except as prescribed in the Regulations of the Company as adopted and agreed upon by the members.

**ARTICLE VIII - MANAGEMENT**

The Company shall be managed by the members in accordance with the Regulations of the Company as adopted and agreed upon by the members and the name(s) and address(es) of the managing member(s) is/are as set forth in Article IX below.

**ARTICLE IX - MEMBERS**




