**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be Abbianna, L.C. ("company").

**ARTICLE II
ADDRESS**

The mailing address of the principal office of the company shall be Abbianna, L.C., Post Office Box 10805, Tallahassee, Florida 32302; the street address shall be 519 East Park Avenue, Tallahassee, Florida 32301.

**ARTICLE III
DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall terminate not later than December 31, 2040, unless the company is earlier dissolved as provided in these articles of organization or unless the company is continued by the written consent of at least two remaining members.

**ARTICLE IV
REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the company in the State of Florida is Stuart A. Christmas, 1545 Raymond Diehl Road, Suite 150, Tallahassee, Florida 32308.

**ARTICLE V
CAPITAL CONTRIBUTIONS**

The members of the company shall contribute to the capital of the company the amount of \$10,000.00.

**ARTICLE VI
TRANSFER OF INTEREST; NEW MEMBERS**

A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

**ARTICLE VII
TERMINATION OF EXISTENCE**

The company shall be dissolved on the death, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members, provided there are at least two remaining members.

**ARTICLE VIII
MANAGEMENT**

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. The regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
