**ARTICLES OF ORGANIZATION  
OF  
PRIMESAT, LLC**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I  
NAME OF COMPANY**

The name of the limited liability company is PRIMESAT, LLC (the "Company").

**ARTICLE II  
PERIOD OF DURATION**

The Company shall exist perpetually, unless sooner dissolved in accordance with the Company's Regulations or Florida law.

**ARTICLE III

**ARTICLE V**  
**DISSOLUTION AND RIGHT TO CONTINUE BUSINESS**

The Company shall be dissolved upon the first to occur of the following:

- (a) The expiration of the term of the Company;
- (b) The unanimous written consent of all the Company's members;
- (c) Upon the death, retirement, resignation, expulsion, dissolution or bankruptcy of a member, or any other event which terminates the membership of a member in the Company, the existence and business of the Company shall be continued by the remaining members without the necessity for the consent or vote of the members.

**ARTICLE VI**  
**MANAGEMENT**

The Company will be managed by managers (the "Managers"). The Managers shall be elected annually by the members in the manner prescribed by and provided for in the Operating Agreement of the Company. The Managers shall also hold the offices and have responsibilities accorded to them by the members and as set forth in the Operating Agreement of the Company. 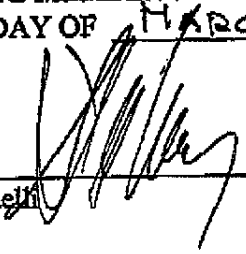
