ARTICLES OF ORGANIZATION OF SUMMIT EAST MANAGEMENT, L.L.C.

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter

RTICLE I - Name

The name of the this limited liability company is Summit East Management, L.L.C. ("Company").

ARTICLE II - Duration/Purpose

The Company shall exist perpetually, and it shall be authorized to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - Address

The mailing and street address for the principal office of the Company is 3372 Capital Circle, N.E., Tallahassee, Florida 32308

ARTICLE IV - Admission of Additional Members

Additional members to the Company may be admitted in accordance with the Operating Agreement.

ARTICLE V - Members Rights to Continue Business

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.

ARTICLE VI - Management

The daily, usual course of business of the Company will be managed by a manager (the "Manager"). The Manager shall be elected annually by the members in the manner prescribed by and provided for in the Operating Agreement of the Company. The Manager shall also hold the offices and have responsibilities accorded to him by the members and as set forth in the Operating Agreement of the Company. The members reserve the general management of the Company to themselves, and therefore all decisions outside the usual course of the Company's business will require a vote of the members holding two-thirds interest in the Company. ARTICLE VII - Operating Agreement

The members shall have the power to adopt, alter, amend, or repeal Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.

ARTICLE VIII - Registered Agent and Office
