**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I**

**Name**

Members' Rights to Continue Business

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members, if any, may, by unanimous written agreement, continue the business of the Company.


## ARTICLE VIII


