Admission of Additional Members:

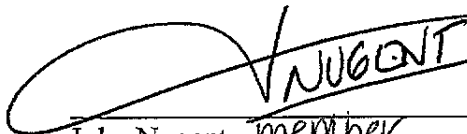
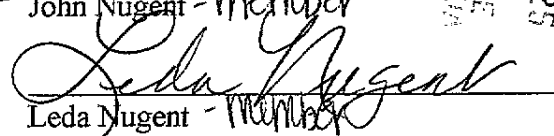
